4. FIRST-AID MEASURES

Inhalation	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. For breathing difficulties, oxygen may be necessary. Call a physician if symptoms develop or persist.

5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media:	Water spray, CO ₂ , dry chemical, or alcohol-resistant foam.
Unsuitable Extinguishing Media:	Do not use solid water stream—it may spread fire.
Protective Equipment:	Firefighters should wear SCBA and full protective gear.
Specific hazards arising from the chemical:	Fire may produce irritating, corrosive and/or toxic gases.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures:	Eliminate all sources of ignition. Avoid contact with skin or inhalation of spillage, dust or vapor. Keep unnecessary personnel away. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering them.
Methods and materials for containment and cleaning up:	Collect and dispose of spillage as indicated in section 13 of the SDS. Absorb with inert absorbent such as dry clay, sand or diatomaceous earth, commercial sorbents, or recover using pumps.

The product is immiscible with water and will spread on the water surface.

Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Never return spills in original containers for re-use.
