2. HAZARD(S) IDENTIFICATION

Physical Hazards:	Not classified based on available information.
Health Hazards:	Contains naturally occurring fragrance allergens, including coumarin. May cause skin sensitisation or irritation in susceptible individuals. Classification should be verified against a manufacturer-issued SDS when available.
